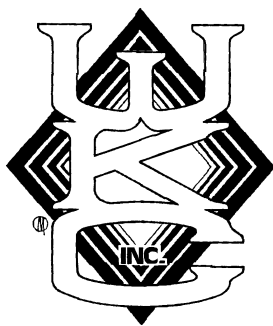

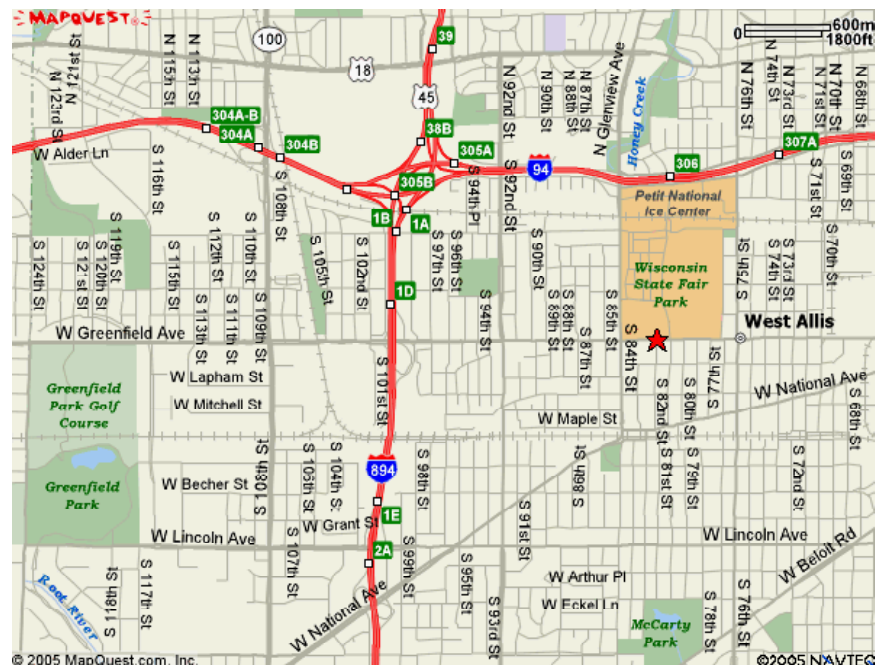

*For Public Parking Please Enter at Gate #1 or Gate #4. For Exhibitor Parking Please Enter at Gate #1 Only.

FROM THE NORTH-Take I-43 South to I-94 West. Go approximately 6 miles and take the 84th Street Exit. Turn Left (South) to Greenfield Avenue. Turn Left (East) on Greenfield Avenue to 79th Street and Turn Left to Enter at Gate #1. Take Highway 45 South to I-894. Continue in a Southerly direction to the Greenfield Avenue Exit. Turn Left (East) on Greenfield Avenue. Take Greenfield Avenue to 79th Street and Turn Left to Enter at Gate #1.

FROM CHICAGO AND OTHER POINTS SOUTH-Take I-94 North to the I-894 Bypass. Take the I-894 Bypass to Greenfield Avenue Exit. Go Right (East) on Greenfield Avenue. Take Greenfield Avenue to 84th Street and Turn Left (North) to Enter at Gate #4 to take Greenfield Avenue to 79th Street and Turn Left to Enter at Gate #1.

FROM THE WEST-Heading East on I-94, take the 84th Street Exit. Turn Right (South) onto 84th Street to Greenfield Avenue. Turn Left on Greenfield Avenue (East) to 79th Street and Turn Left to Enter at Gate #1.

FROM THE EAST-Heading West on I-94, take the 84th Street Exit. Turn Left (South) onto 84th Street Continue to Greenfield Avenue. Turn Left on Greenfield Avenue (East) to 79th Street and Turn Left to Enter at Gate #1.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show-giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging. Numbers before each Breed represent the number of dogs entered in (1) the regular dog classes; (2) regular bitch classes; (3) Specials Only, Best of Breed or Best of Variety Competition; and in (4) Non-Regular classes.
